

# Back-to-School Grants Program Frequently Asked Questions FOR SCHOOL STAFF

## 1. What is Virginia G. Piper Charitable Trust?

Virginia G. Piper Charitable Trust is a private foundation committed to honoring Virginia Galvin Piper's legacy of supporting organizations that enrich health, well-being, and opportunity for the people of Maricopa County. The Trust focuses its grantmaking in six core areas: healthcare and medical research, children, older adults, arts and culture, education and religious organizations. ## 2. Why is my district receiving this grant?

Your school is one of Maricopa County's public elementary schools identified with a significant population of students in need and as such, it was selected by Piper Trust's Board of Trustees for a Back-to-School grant award.

## 3. Can I apply for a grant for our other schools?

There is no application process for the program. The highest-need schools are selected based on data provided by the Arizona Department of Education each year.

## 4. Why were some Title I schools in our district not included?

Title I designation alone is not the defining factor for this program. Schools are selected for Back-to-School grants based on a number of factors which include; Free and Reduced Lunch Program data, enrollment numbers, and grades served. Some schools that have schoolwide Title I designation may not meet other requirements for this grant program.

## 5. What can and can't these funds be used for?

Piper Trust's Board of Trustees want to help ensure that children in need have necessary school clothing and shoes; funds must be used to purchase only these items. Funds may not be used for personnel, transportation costs, or school supplies.

## 6. How do schools use these funds?

These grant funds are intended to augment the valuable support provided by Back-To-School Clothing Drive, Assistance League chapters, and other nonprofit organizations and can be used

throughout the year as emergency needs arise. Some grantee schools have leveraged their funds by negotiating partnerships with local stores to purchase clothing at a discounted rate. Schools are encouraged to use this approach and seek discounts and/or matching fund opportunities.

Three local nonprofit agencies offer programs that provide assistance with clothing and uniforms.

## Changes to Piper Trust's Back-to-School Grants Program for the 2016/17 School Year

- For the 2016/17 school year, Back-to-School clothing grants are awarded for a three-year grant term, covering the 2016/17, 2017/18, and 2018/19 school years. Recipient schools will receive the same grant award each year of the grant term as long as the school remains open and is serving the same mix of grades. This shift will provide greater predictability for recipient schools and streamline administration of the grants.
